

## Press Release

European Network of Transmission System Operators for Gas (ENTSOG) launches the call for information on infrastructure projects to be included in TYNDP 2015. This is the first step for the selection of Projects of Common Interest (PCI).

**(PR069-14, Brussels, 3 July 2014)** The European Network of Transmission System Operators organized its 9<sup>th</sup> TYNDP/CBA Workshop in Vienna end of June. During this event, the adapted Cost Benefit Analysis methodology and the collection process for infrastructure projects for TYNDP 2015 (covering the 2015-2035 time horizon) was presented.

According to article 2.4 of the Annex III of Regulation (EC) 347/2013, promoters wanting to apply for the second selection of PCI shall be part of TYNDP 2015 and therefore submit their projects through the present call for information.

Vittorio Musazzi, ENTSOG General Manager said: "The role of the TYNDP in the assessment of European gas infrastructures has been growing over the years. With the New TEN-E Regulation it will serve as an entryway into the Project of Common Interest process. It is therefore particularly important for promoters to provide us with accurate and timely data."

As two years ago, ENTSOG hereby launches a public call for data regarding gas infrastructure projects that should be covered in the TYNDP 2015. All project promoters that consider their projects eligible for entry should submit:

- > By the 8 August 2014 all modelling data (capacity increments, expected date of commissioning, FID status and PCI label as resulting from the first selection)
- > **By 12 September 2014** all other mandatory information

Data will be collected exclusively through an online questionnaire. Project promoters are required to approach ENTSOG to receive credentials and the user manual to enter the data collection system. Project promoters that submitted their projects for the TYNDP 2013-2022 or the second edition of the GRIPs must confirm their entry for TYNDP 2015 and submit up-to-date



data otherwise their projects will not be covered and therefore will not be able to take part to the second PCI selection.
