## ENTSOG publishes its Annual Report 2020 and two Monitoring Reports

(Brussels, 4 May, PR0238-21) **Today, ENTSOG publishes its Annual Report 2020 and Implementation and Effect monitoring reports for the Capacity Allocation Mechanism Network Code (CAM NC) and Congestion Management Procedure Guidelines (CMP GL).** 

The Annual Report assesses ENTSOG's work and achievements retrospectively for the previous year and explains the delivered results vis-à-vis ENTSOG's Annual Work Programme.

Throughout the COVID-19 pandemic, ENTSOG members ensured through their operations and procedures that business continuity and essential services were maintained. ENTSOG continued to deliver on planned tasks and outputs, including publication of the final Ten-Year Network Development Plan (TYNDP) 2020 Scenarios Report, and the draft TYNDP 2020.

The ENTSOG 2050 Roadmap Action Plan was published in October and outlined its engagement proposal for dialogue with experts and policy makers in preparation for the upcoming Hydrogen and Gas Market Decarbonisation Package. In 2020, ENTSOG contributed to European Commission consultations on Energy System Integration and Hydrogen Strategies, as well as on revisions of the EU rules on Trans-European Networks for Energy (TEN-E Regulation) and EU Renewable Energy Directive (RED II).

Jan Ingwersen, ENTSOG General Director, commented, "ENTSOG welcomes European Commission's acknowledgement in the recent stakeholder consultations of the continued role of the existing gas grids by efficient repurposing and retrofitting to transport hydrogen and other low carbon gases. We find it important to maintain and develop competitive and decarbonised European gas markets for all gases, to ensure continued security of supply as well as to contribute to the decarbonisation of Europe's energy sector."





The monitoring reports represent an overview of the implementation and effect status of the CAM NC and CMP GL at the end of 2020. The reports show that progress has been made towards full implementation of CAM NC and CMP GL provisions when compared with the results of the previous monitoring reports.
