ABOUT YOUR ROLE AS SYSTEM OPERATION DIRECTOR

ENTSOG is looking for candidates that have **relevant managerial experience** in a challenging and rapidly developing EU energy environment and upcoming objectives resulting from EU energy and climate policy. The ENTSOG System Operation Area facilitates the implementation and monitoring of key EU legislation and contributes to further developing the EU legislation in the areas of Interoperability and Transparency.

The Candidate will participate into the debate on the technical aspects with focus on **Security of Supply, Gas and Hydrogen quality, Interoperability, Transparency and REMIT, Data Exchange and Cybersecurity** including other matters as may be determined by regulation and ENTSOG.

CANDIDATE REQUIREMENTS

The Candidate will be **based in Brussels** and should be ready to start work as soon as possible **at the latest during Q3 of 2024**.

Appointees from ENTSOG Members will be seconded based on a contract between ENTSOG and the seconding TSO, usually for a period of 3 years.

KEY RESPONSIBILITIES

Key responsibilities of the Director includes management of the System Operation Team, **managing/planning** the various activities, **leading/participating** in ENTSOG working groups, **representation** of the Area's activities towards ENTSOG decisional bodies, representation in external workshops and meetings as well as **participation** in processes led by the European Institutions.

The Director will need to **build, maintain and enhance an extensive network of both working and higher level contacts** with ENTSOG members representatives as well as many key actors including the EC, ACER, European Parliament, NRAs, EU member states representatives and gas and other energy stakeholder organisations like ENTSO-E, MARCOGAZ, CEN, EASEE-gas, Hydrogen Europe, ENISA and others.

CANDIDATES SHOULD HAVE:

- ▲ Substantial (at least 10 years) gas industry experience, preferably from a gas Transmission System Operator,
- ▲ technical background, preferably a degree in engineering or equivalent by experience,
- ▲ vast knowledge on topics such as SoS, interoperability of TSOs networks, EU transparency requirements, REMIT and others,
- ▲ an understanding of the potential future gas market and technical developments that may be needed to improve the current market and to meet future requirements,
- ▲ knowledge on the European gas network,
- ▲ knowledge on renewable and/or decarbonized gas, climate change debate, new uses of gas and other relevant issues,
- ▲ profound understanding of the potential future energy system developments that may be needed to meet,
- ▲ proven managerial and inter-relational skills, skills in terms of managing the Brussels team members as well as in handling the ENTSOG working groups and member representatives,
- ▲ empathy and effective communication skills as well as adaptability to embrace change and to guide the team through transitions,
- ▲ ability to take decisions in a demanding environment with diverse variables and high complexity,
- ▲ well-developed skills in presentation on complex issues as well as in drafting reports/papers, addressing both expert and/or non-expert audience,
- ▲ fluent English language both in writing and speaking.

The Director will have a **team of approximately 8 people** supported by Subject Managers and will be responsible for the management and the deliverables assigned by ENTSOG General Director and Board.
