ENTSOG announces the ENTSOG President, General Director and Board Members for new term of 1 January 2025 until 31 December 2027

(Brussels, 12 December 2024, PR0331-24) **Today, in their 60th General Assembly, the ENTSOG Members have elected the President and Members of the Board for the term 1 January 2025 to 31 December 2027.**

The ENTSOG General Assembly re-elected Bart Jan Hoevers as ENTSOG President.

Bart Jan commented, *“With the newly enacted Hydrogen and Decarbonised Gas Markets Regulation, we are ready to face the next chapter of the energy transition, while maintaining the gas grids’ role as reliable, resilient, flexible and affordable infrastructure. It is a great honour to be re-elected to this position and my priority is to ensure the ongoing open and transparent stakeholder engagement.
