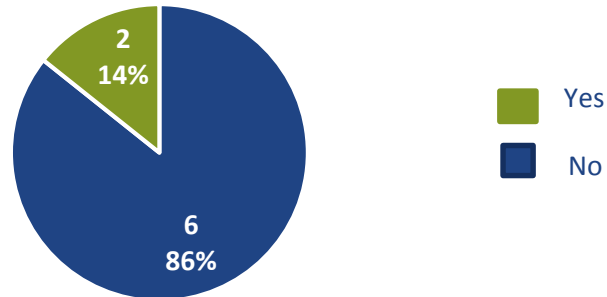

Usage Profile	Comments Received	ENTSOG Response
Interactive	Clarification requested for the Upload/Download Possibilities	This is already in the plan for 2018 activities
Interactive	To have the English Language as Mandatory	This cannot be mandatory but is stated in the profile as should be provided
Interactive	Some of the commonly used web browser should be named	It is preferred not to limit choice, ENTSOG consciously decided on the current wording 'Recent versions of commonly used Web Browsers must be supported'
Integrated	Currently not chosen for any solution but hopes this can replace the capacity deal capture part to avoid unsecure emails with bookings	ENTSOG to investigate further the development of use cases for Integrated Data Exchange possibilities
AS4/Document Based	Planned update frequency for the ENTSOG AS4 Profile	The profile has been updated twice yearly following feedback from market participants, this has been to clarify ambiguities and to introduce non mandatory newly developed functionality. It is not planned to increase the update frequency, in reality 1 update a year may be more likely.

Common to all Profiles	Some confusion between the Profiles and the use cases	Short introductory documentation being developed for smaller market participants and those who are not so familiar with the regulation.

As stated earlier we do not like the interactive approach at all since it introduce a big risk when it comes to booking and deal capture connected to capacities for companies that buy capacities on more than one or two connection points. When that is said we hope this document will push the platforms forward in a direction that at a later stage will make it easier for them to support the already existing standard for capacity trading (edig@s). We hope the document will develop in a direction with clearer statements. One example is the statement "Recent versions of commonly used Web Browsers must be supported" maybe some of the commonly used web browser should be named and it should also be clear that the new and the previous version should as a minimum should be supported at all time. We think it is positive that ENTSOG push the platforms to harmonize the content of the portals but think the document is to unclear in the "Upload/Download Function"
